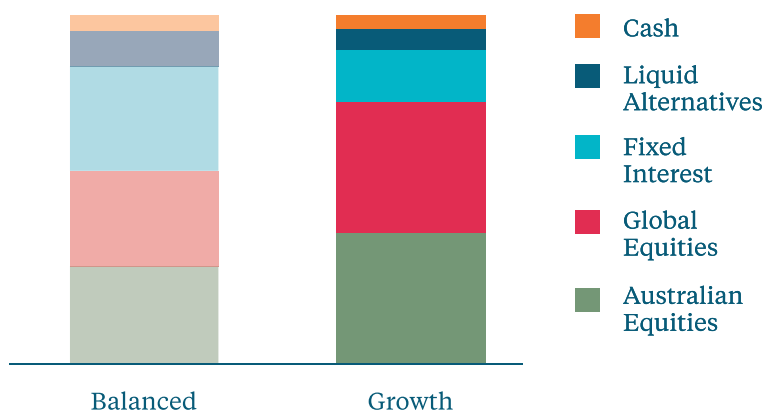

## The building blocks of our diversified portfolios



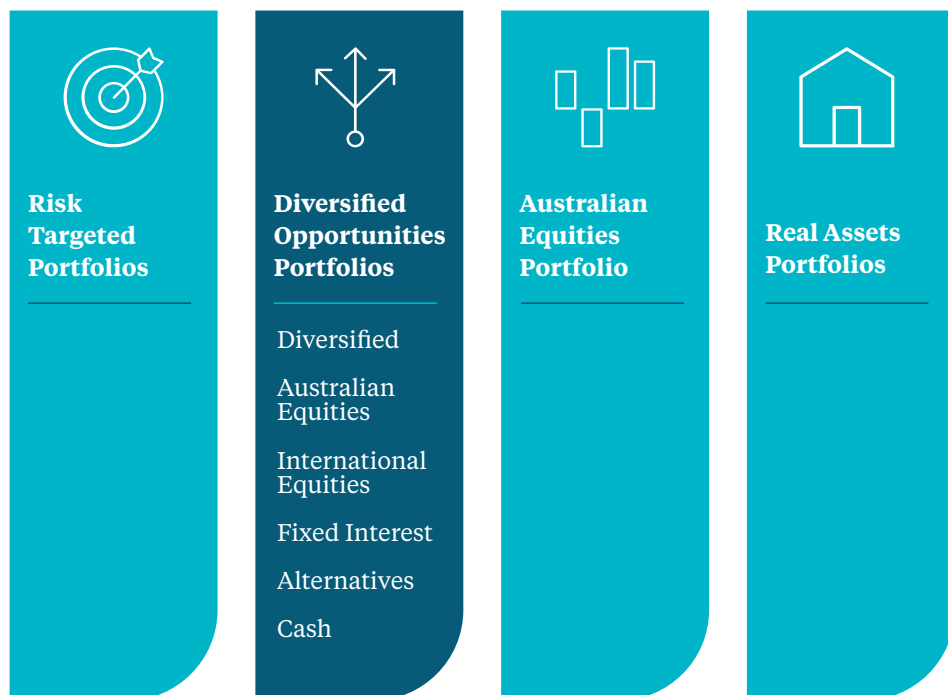

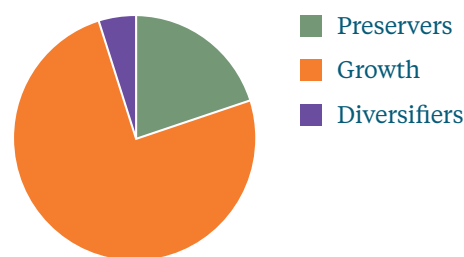


## What is MAPS
