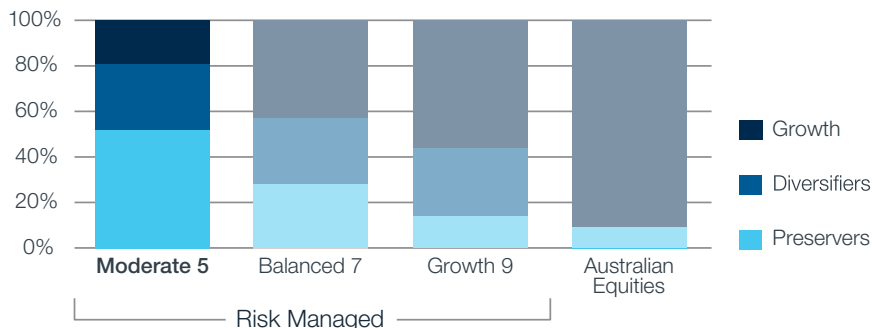


### APPROACH TO INVESTING

**Preservers** – assets that protect the portfolio during periods of heightened equity market volatility.

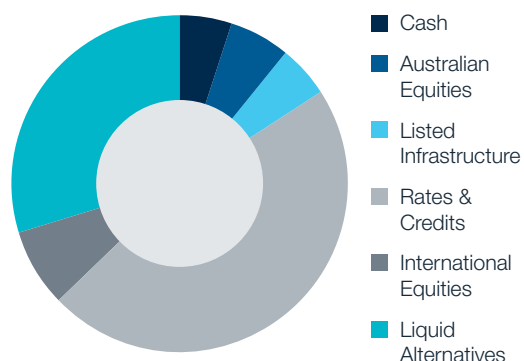
**Growth Assets** – assets that are expected to deliver higher rates of return over time with higher levels of associated volatility (risk).
